### Our EHS&S Principles

**Workplace Safety:** Our objective is to provide healthy and safe places to work. We engage with our people and stakeholders to continuously improve and proactively identify and control workplace hazards. Our leaders at all levels are held accountable, and take action by observing, engaging, and improving what we do. We take responsibility to eliminate hazards and reduce health and safety risks. We empower our employees to act in a safe manner and encourage workers to report incidents and risks and to contribute suggestions for improvement. Through consultation and feedback from our workers, workplace health and safety information is promulgated.

**Employee Wellness:** We provide resources to promote a productive and healthy lifestyle and employee work-life balance. We provide employees with training, and opportunities to promote personal and professional development. We foster an inclusive workforce where all employees can thrive and offer benefits that support positive mental health.

**Regulatory Compliance:** We meet or exceed all local laws and requirements related to EHS&S regulations. We have an established global EHS&S management system aligned with globally recognized best practices and standards, including our commitment to achieving ISO 14001 certification for all our manufacturing sites.

**Responsible Procurement:** We are committed to procuring materials, goods, and services responsibly. We encourage our direct suppliers to embrace best

practice through appropriate certifications and management systems. We regularly review supplier products and services to inform the selection of new suppliers.
